Minutes of Meeting  
April 24, 2007

**Meeting** called to order at 5:00 pm.

Those in **attendance**: Tiffany Marsh, Debbie Slattery, Kay Shanker, Jennifer True, Amy Bird, and Barbara Atwood.

**Fundraiser:** Candy sales - still have 4 cases to sell - suggestion by Kay Shanker to ask if we can sell the remaining candy at Saturday's Male Pageant.  
Cookie Dough for next year - do we want to stay with Larry Moore Fundraising? - offers 41% profit - has tub cookie dough; or switch to Bumblebee Fundraiser? - offers 40% profit - has break 'n bake cookie dough. We have set a tentative date beginning September 10th. Kay Shanker mentioned that this is late because other groups from Western Hills and Bondurant do the cookie dough fundraiser earlier. Is there possibly an earlier date with Moore Fundraising?

Tiffany Marsh mentioned again that at the summer booster planning meeting in June the committee needs to revamp fundraising. Decide on which ones to keep and which ones to replace.

May 5th is the **Derby breakfast** performance. Chorale students need to be there in "dressy" attire/not concert black at 6:45 a.m. They will perform from 7:30 a.m. - 7:50 a.m. Marsh informed the parents at the meeting that students will receive parking and breakfast passes prior to the event. Barbara Atwood said to contact her by next Wednesday if Marsh has not yet received the passes in the mail. Barbara Atwood also suggested taking donations or selling candy at the breakfast. She said that she would find out if either would be possible.

**Choral Banquet update:** Saturday, May 19th at 6:00 at Immanuel Baptist on Collins Ln. There are 12 seniors in the choral department. Booster members discussed senior gifts for this year. Jennifer True mentioned bags from Lands End are too expensive. Ideas were thrown out to get cheaper bags and fill. Marsh presented an engraved picture frame as a possible gift for seniors. Members thought this would be a good idea and also give a \$10 Kroger gas card. This route would be easier and cheaper. 2005-2006 senior gifts totaled \$210.55.

\$10 tickets will be sold again for the banquet to ensure people who reserved will get food. ONLY senior choir members will be paid for.

May 17th is the choral department's **Ice Cream Concert** which will be held at 6:30 p.m. in the auditorium. Tiffany Marsh asked if any parents would be willing to contact businesses for donated items such as ice cream, bowls, spoons. Amy Bird agreed to make phone calls. Possible businesses were suggested: Kroger, Walmart, Captain D's.

**Schedule Update:** Spring Concert (for Chorale & Chamber Choir only) moved to May 31st at 7:30 p.m. at Church of the Ascension. This was moved from May 20th due to the banquet on May 19th. Baccalaureate will be held on Sunday, June 3rd and Graduation on Sunday, June 10th.

Tiffany Marsh referred to the email she out prior to the meeting regarding new **Booster Officer** nominations/suggestions. Marsh mentioned that the positions of President and Vice President will have to be filled because Jennifer True and Connie Miller will be leaving. Kay Shanker stated that she is willing to stay on as Treasurer. Kay also mentioned that she spoke with Teresa Lewis and Kellie Lang as possible officers. Marsh said that she doesn't know whether Lisa Triplett would want to remain in the position of Secretary or if it is too much since she cannot make many meetings. Suggested by Barbara Atwood that Ruth Booth would be a good person to get involved. Marsh said she would talk with her. Kay Shanker nominated Barbara Atwood as President - Barbara accepted nomination. Marsh asked if Amy Bird would be interested in a position. She said she could accept a nomination for the Fundraiser Chairperson.

**Treasurer's Report** was given by Kay Shanker. The balance is above \$5000 due to the candy sales fundraiser.

Tiffany Marsh reminded the members in attendance of the **Summer Booster Planning Meeting** which will be held on Thursday, June 14th at the Marsh house in Midway. We will be reviewing the fundraising plan. Some dates will already be in place for the following year. Both old and new booster officers and members are invited to attend. Jennifer True mentioned she will not be able to attend due to vacation.
